We Have Officially Formed!

On Tuesday, March 3rd, 2009 many fine and upstanding citizens from your neighborhood were in attendance for the purpose of forming a Neighborhood Association. At 6:30pm at Washington Middle School, the local neighborhood came together to form the President's Neighborhood Association.

Purpose

The purpose of the Neighborhood Association is to enhance the livability of the neighborhood and to establishing and maintain an open line of communication and liaison among the neighborhood, government agencies, and other neighborhoods. The neighborhood association will provide an open process by which all members of the neighborhood may involve themselves in the affairs of the neighborhood.

Our Goal

Our neighborhood has been on the decline over the many years. We are making an effort to curb and reverse this trend. There are many resources that can be made use of to better improve your environment and ultimately your life. This along with many other services can be performed from a neighborhood level organization that could not otherwise be obtained.

What Are The Boundaries?

The jurisdictional boundaries are Washington Ave. on the north, Weinbach Ave. on the east, Covert Ave. on the south, and Highway 41 on the west.



Who?

Your neighbors mostly. There are people from all walks of life that are involved in helping out. We have a lot of projects on the table that need attention. We are forming teams and making policy. Please come and join us as we mold our neighborhood back into shape.

When and Where?

The meetings are held the first Tuesday of every month in the Auditorium at Washington Middle School. Meetings begin at 6:30pm sharp and generally last 2 hours. The auditorium is located on the west side of the school. The entrance is the only double white door that faces west.

President's What?

Your Neighborhood is comprised of six Presidential streets. Starting from the most northern street and the first President of our country, Pres. George Washington Ave., followed by Pres. John Adams Ave., Pres. James Madison Ave., Pres. James Monroe Ave., Pres. Andrew Jackson Ave., and Pres. Zachary Taylor Ave. The Neighborhood Association therefore inherited the name of the "President's Neighborhood Association".

Membership Dues

Like any organization we must raise money. Annual Dues are as follows:

- \$5/year Full Time Student
College Level Student.
- \$10/year Individual membership
Single person household.
- \$15/year Household membership
Covers entire household, regardless of person count.
- \$20/year Commercial membership
Cost for any facility that is not designated as residential.
- \$30/year Sponsor membership
Individuals who wish to give more than the minimum.

Heavy Trash Pickup

Heavy Trash Day for our neighborhood is set for May 1st. Heavy trash includes furniture, appliances, televisions and stereos, building materials and old fencing. When you set out heavy trash, please follow these guidelines.

- 1) Place heavy trash wherever garbage is normally collected from your home, whether at the curb or in an alley
- 2) Set out items before 6 a.m. on the scheduled collection day
- 3) Make sure piles are manageable, and don't restrict either pedestrian or vehicular traffic
- 4) Put all loose materials into a container.
- 5) Roll carpet into sections no more than 4 feet long and 2 feet in diameter.
- 6) Place no more than two large appliances out for collection. Most appliances can be recycled. (However, scrap and junk collectors will usually take as many as you have before the city ever has a chance to get to your house.)
